AFFIDAVIT OF KATHLEEN WELLS IN SUPPORT OF EPISCOPAL PARTIES' MOTIONS FOR PARTIAL SUMMARY JUDGMENT

BEFORE ME THE UNDERSIGNED AUTHORITY, on this day personally appeared KATHLEEN WELLS, who, being by me personally sworn, upon her oath stated:

- 1. My name is Kathleen Wells. I am over eighteen years of age, of sound mind, and fully capable and competent to make this Affidavit. I have personal knowledge of the facts stated herein, and all facts stated herein are true and correct.
- 2. Since February 7, 2008 I have served as the Chancellor of the Episcopal Diocese of Fort Worth (the "Diocese"), which is a subordinate unit of the Protestant Episcopal Church in the United States of America ("The Episcopal Church"). I also served as a delegate from my parish, Trinity Episcopal Church in Fort Worth, to the annual meetings of the Diocesan Convention in 2007, 2008, and 2009, respectively, and also to the special meeting of the Diocesan Convention on February 7, 2009 for the Episcopal Diocese of Fort Worth. I also served as a deputy from the Episcopal Diocese of Fort Worth to the meeting of the General Convention of The Episcopal Church in 2009 and now serve on the Church's Standing Commission for Constitution and Canons.
- 3. In September 2008, then-Bishop of the Diocese Jack Leo Iker produced various written statements advocating that the congregations and members of the Diocese should separate from The Episcopal Church and "realign" with the Anglican Province of the Southern Cone. True and correct copies of two such statements are attached as **Exhibits 1 and 2**.
- 4. At the November 14-15, 2008 annual meeting of the Diocesan Convention, which I attended, the breakaway faction led by Iker purported by local majority vote to sever the

Diocese's ties with The Episcopal Church by purporting to replace Article I of the Diocesan Constitution, which stated that "[t]he Church in this Diocese accedes to the Constitution and Canons of the Episcopal Church in the United States of America, and recognizes the authority of the General Convention of said Church," with the following text:

The Episcopal Diocese of Fort Worth is a constituent member of the Anglican Communion, a Fellowship within the One, Holy, Catholic, and Apostolic Church, consisting of those duly constituted Dioceses, Provinces and regional churches in communion with the See of Canterbury, upholding and propagating the historic Faith and Order as set forth in the Old and New Testaments and expressed in the Book of Common Prayer.

A true and correct copy of the Report from the Constitution and Canons Committee to the 26th Annual Convention of the Episcopal Diocese of Fort Worth, recommending this change to the Diocesan Constitution, is attached hereto as **Exhibit 3**.

- 5. At the November 14-15, 2008 annual meeting, the Diocesan Convention also purported to adopt the breakaway faction's "Proposed Resolution for Admission to the Anglican Province of the Southern Cone," which stated in relevant part that the Diocese "does hereby accept the provision made by the Anglican Province of the Southern Cone, and the Episcopal Diocese of Fort Worth does hereby immediately enter into the membership with the Anglican Province." A true and correct copy of this proposed resolution is attached to this Affidavit as **Exhibit 4**.
- 6. By these actions at the November 14-15, 2008 annual meeting of the Diocesan Convention, the breakaway faction purported to cause the Diocese to join a church located in South America, the Anglican Province of the Southern Cone, that is not a part of The Episcopal Church. Attached hereto as **Exhibit 5** is a true and correct copy of a November 16, 2008 statement by the breakaway faction entitled "As We Realign," in which the breakaway faction

claims to have "withdrawn from the General Convention" and "realigned with another Province of the Anglican Communion."

- 7. On November 24, 2008, the former members of the Standing Committee of the Diocese—The Rev. Christopher Cantrell, The Rev. Thomas Hightower, Judy Mayo, The Rev. Timothy Perkins, Frank Salazar, and Walter Virden—and Bishop Iker published their response to the Presiding Bishop's inhibition of Iker on November 21, 2008, clearly indicating that they did not consider themselves to be part of The Episcopal Church. A true and correct copy of that response is attached hereto as **Exhibit 6**.
- 8. On February 7, 2009, the Presiding Bishop of The Episcopal Church, The Most Rev. Katharine Jefferts Schori, called to order a Special Meeting of the Convention of the Episcopal Diocese of Fort Worth after acknowledging that, at that time, there was "no Bishop of the Episcopal Diocese of Fort Worth, or any qualified members of the Standing Committee of that Diocese." Attached hereto as **Exhibit 7** is a true and correct copy of the Notice of Special Meeting of the Convention of the Episcopal Diocese of Fort Worth from the Presiding Bishop.
- 9. The individual defendants other than Bishop Iker assumed their respective positions as Trustees of the Diocesan Corporation, Trustees of the Fund for the Endowment of the Episcopate, and members of the Standing Committee of the Diocese on or at various times prior to November 15, 2008, by virtue of their qualification at the time of their election under diocesan canons as lay persons in good standing of a parish or mission in the Diocese, or members of the Clergy canonically resident in the Diocese, and their election to those offices by the Diocesan Convention. Before and after the breakaway faction purported to sever ties with The Episcopal Church and affiliate with the Anglican Province of the Southern Cone, the

continuing local members of The Episcopal Church have continued to worship in Fort Worth as part of The Episcopal Church and its Episcopal Diocese of Fort Worth.

- 10. The Diocese has consistently sent representatives to meetings of both houses of The Episcopal Church's General Convention, including to the Convention's most recent meetings in 2006 and 2009.
- 11. Since before I became a member of The Episcopal Church in Fort Worth in 1987, The Episcopal Church has been providing religious services in the north-central Texas area continuously using (1) the name "Episcopal Diocese of Fort Worth" and (2) a graphical depiction of a shield (the "Diocesan Shield"). Until on or about November 15, 2008, I was aware of no other organization that identified itself by (1) the name "The Episcopal Diocese of Fort Worth" or (2) the graphical depiction of a shield used to identify the Diocese. Reproduced below is a true and correct copy of the Diocesan Shield.



12. Through this use, the Episcopal Diocese of Fort Worth, as a unit of The Episcopal Church, has established substantial goodwill in the name "Episcopal Diocese of Fort Worth" and in the Diocesan Shield. Those rights have been recognized by the United States Patent and Trademark Office, which granted Federal Registration Nos. 3,820,400 (name) and 3,826,996

(seal) for the service marks. True and correct copies of the certificates of registration from the United States Patent and Trademark Office are attached hereto as **Exhibit 8**.

13. After the breakaway faction purported to disaffiliate from The Episcopal Church and purported to "realign" the Diocese with the Anglican Province of the Southern Cone, that breakaway faction continued to use the name "Episcopal Diocese of Fort Worth" and the Diocesan Shield in connection with their provision of religious services. This has included use and display of the name "Episcopal Diocese of Fort Worth" and the Diocesan Shield in official communications, on the breakaway faction's website, http://www.fwepiscopal.org, and on various mailings and other publications. Attached as **Exhibit 9** are true and correct copies of examples of such unauthorized uses of the Diocesan name and shield.

14. Attached hereto are true and correct copies of the following documents issued in conjunction with the annual meetings of the Diocesan Convention in 2007 and 2009, respectively:

a. Excerpts from the Journal of the annual meeting of the Diocesan Convention in 2007 (Exhibit 10);

b. Excerpts from the Journal of the special and annual meetings of the Diocesan Convention in 2009 (Exhibit 11).

15. Attached hereto is a true and correct copy of the text of Canon 11 "Corporation of the Episcopal Diocese of Fort Worth," applicable from 1982 – 1989, and then renumbered in 1989 as Canon 17 "Corporation of the Episcopal Diocese of Fort Worth," applicable through 2008, of the Canons of the Episcopal Diocese of Fort Worth (Exhibit 12).

From the Bishop and Standing Committee • Sept. 8, 2008

On Wednesday, Sept. 10, 2008, the Executive Council of the diocese adopted and endorsed - with only one dissenting vote - the following report and recommendation of the Bishop and Standing Committee.

The recommendation of this third report made in response to Resolution 2 of the 25th Annual Convention of the diocese will be presented to clergy and delegates to the upcoming 26th Annual Convention for consideration on Nov. 14 & 15, 2008.

Third Report

from the Bishop and Standing Committee concerning The Anglican Province of the Southern Cone

A resolution adopted by the 25th Annual Convention of the Episcopal Diocese of Fort Worth requested "that the Bishop and Standing Committee prepare a report for this diocese on the constitutional and canonical implications and means" of becoming a member diocese of the Anglican Province of the Southern Cone. Two preliminary reports* have been made — one on January 9, 2008, and another on February 12, 2008 — and both should be reviewed at this time, for they are an integral part of the recommendation we are making to the 26th Annual Diocesan Convention.

After months of prayerful discernment and extensive consultation with others, both within our own diocese and beyond, we have come to the following conclusion. We recommend that this Diocese affiliate with the Anglican Province of the Southern Cone as a member diocese, on a temporary, pastoral basis, until such time as an orthodox Province of the Anglican Communion can be established in North America.

We have been in conversation about this matter with the Committee on Constitution and Canons, and they will be presenting to Convention the necessary changes to our constitution and canons to enact this realignment.

We pray for God's grace to uphold and guide us in the days ahead and for the Holy Spirit to continue to inspire us "with the spirit of truth, unity and concord" as we seek to serve and glorify the Lord Jesus Christ.

10 Reasons Why Now Is the Time to Realign

Our 26th annual convention is approaching, and a momentous decision is before us as a diocese. At last year's convention, your clergy and elected delegates voted by majorities of around 80 percent each to remove language in our Constitution that affiliates us with the General Convention of The Episcopal Church (TEC). This year, clergy and delegates will be asked to ratify that decision to separate.

"Why now?" someone might ask. "Why is this the time for our diocese to separate from the General Convention of The Episcopal Church and realign with another Province of the Anglican Communion?"

Here are a few of the thoughts that come to mind:

- 1. This is God's time our *kairos* moment and it has been coming for a long time. We believe that God the Holy Spirit has guided and directed us to this particular time and moment of decision. Some might well ask, "Why has it taken us so long to take definitive action, given the past 30 years of the shenanigans of The Episcopal Church?" We have explored every avenue and exhausted every possibility. Now is the time to decide to separate from the moral, spiritual, and numerical decline of TEC.
- 2. Actions of the General Convention have brought crisis and division to the whole Anglican Communion, not just TEC. More than 20 of the Provinces of the Communion have declared themselves to be in a state of broken or impaired communion with TEC because of the ordination of a homosexual bishop living in a sexual relationship with another man and the blessings of same-sex unions in many places throughout this church. We need to dissociate ourselves from the bishops and dioceses that are violating the teaching of Scripture by doing these things.
- 3. The heresies and heterodoxy once proclaimed by just a few renegade bishops like James Pike and John Spong are now echoed by the Presiding Bishop, who is the chief spokesperson for TEC and speaks on behalf of our church to the rest of the world. She does not reflect the orthodox beliefs of Episcopalians in this diocese. The greatest problem we face with Katharine Jefferts Schori is not that she is a woman, but that she is not an orthodox bishop.

- 4. If we do not act now, we will lose our momentum and lose our God-given opportunity. Many laity and clergy who have been standing with the Diocese, as a beacon of hope, will give up and leave for other Anglican bodies. We will never be stronger than we are right now! We will never have another chance to act with such a strong majority. The Episcopal Church many of us were born into or became members of many years ago no longer exists! It has been replaced by a liberal, revisionist sect that does not deserve our allegiance or support any longer.
- 5. TEC is not turning back and matters will only get worse. General Convention is out of control and beyond reform. The Deputies seem to think that they can do whatever they want as long as they can muster a majority vote, even if what they propose is contrary to Holy Scripture. We will not accept majority votes of the General Convention that compromise the Christian ?faith. The more they change the teachings of the church, the less tolerant they are of dioceses such as ours. By the time I retire (in the next 7 to 13 years), this diocese will be unable to elect an orthodox bishop to succeed me.
- 6. TEC is coming after us, and they are the ones that brought on this crisis. In October 2006 the chancellor to the PB wrote a letter to our diocese demanding that we change our Constitution to remove the clause that says that we will not accept General Convention dictates that are contrary to the Bible and the apostolic teaching of the church. In addition, we were instructed to remove provisions stating that all church property in this diocese is held in trust for the use of our congregations and to state instead that our property ultimately belongs to TEC. If we don't make such changes, the letter asserted that the Presiding Bishop would have to determine what actions she must take "in order to bring your diocese into compliance."
- 7. At this time there is nothing in the Constitution or Canons of TEC that prevents a Diocese from leaving. Oh, I know that General Convention officials claim that dioceses cannot leave TEC, but you will not find that anywhere in the Constitution and Canons as they presently stand. So we have this window of opportunity to do what we need to do, for you can be sure that the next General Convention will close off this option by adopting amendments that will make it even more difficult to separate in the future.
- 8. The vast majority of our younger clergy, those ordained in the last 10 years or so, are in favor of the decision to separate and realign. They are the voice of the future of this diocese; they are the leaders who will take us into the next decade and beyond. You will notice that most of the clergy leaders

opposing this move are already retired or on the verge of retiring. This is not their battle; they have had their time to lead. Now it is time to let this next generation step forward and lead, as we prepare a future for our children and our grandchildren.

9. We have international support for making the move at this time. Not only has the Anglican Province of the Southern Cone made provision for us to join them on a temporary basis as full members and partners in mission, but several Global South Primates are standing with us and have expressed their willingness to support us in this bold move. They have stuck their necks out for us and offered their encouragement, assistance and support. We must now have the courage of our convictions and act! What a joy and relief it will be to be part of a Province where we are not always under attack and on the defensive. We will then aggressively pursue the formation of an orthodox Province in North America in conjunction with the Common Cause Partnership.

10. Most importantly, this decision is about the truth of the Gospel and upholding the authority of the Holy Scriptures. We believe in God's full self-revelation in Jesus Christ, not in the speculation of humanist unitarians who have been elected to high offices in our church. Many leaders of TEC are teaching a false Gospel and leading people astray. Now is the time for us to take a bold, public stand for the biblical faith and practice of the one, holy, catholic and apostolic church.

Now is the time to decide. Our cause is right, and the choice is clear. Let us act together, decisively, and with courage, faith and charity.

REPORT OF THE COMMITTEE ON CONSTITUTION AND CANONS

TO

THE 26TH ANNUAL CONVENTION OF THE EPISCOPAL DIOCESE OF FORT WORTH



PROPOSED CONSTITUTIONAL AMENDMENT B (Presented as D last year)

This was presented to the Twenty-fifth Annual Convention of the Episcopal Diocese of Fort Worth. It was adopted last year with amendments. This is being submitted for the second reading.

Right Reverend Sir:

On behalf of the Committee on Constitution and Canons, we present the following amendment to Article 1 of the Constitution of this Diocese, as proposed by the Standing Committee:

Existing text:

ARTICLE 1

AUTHORITY OF GENERAL CONVENTION

The Church in this Diocese accedes to the Constitution and Canons of The Episcopal Church, and recognizes the authority of the General Convention of said Church provided that no action of General Convention which is contrary to Holy Scripture and the Apostolic Teaching of the Church shall be of any force or effect in this Diocese.

Proposed text:

ARTICLE 1

ANGLICAN IDENTITY

The Episcopal Diocese of Fort Worth is a constituent member of the Anglican Communion, a Fellowship within the One, Holy, Catholic, and Apostolic Church, consisting of those duly constituted Dioceses, Provinces and regional churches in communion with the See of Canterbury, upholding and propagating the historic Faith and Order as set forth in the Old and New Testaments and expressed in the Book of Common Prayer.

The Committee on Constitution and Canons unanimously recommends adoption.

PROPOSED RESOLUTION FOR ADMISSION TO THE ANGLICAN PROVINCE OF THE SOUTHERN CONE

BE IT RESOLVED, that the Episcopal Diocese of Fort Worth, meeting in its 26th Annual Convention, does hereby accept the provision made by the Anglican Province of the Southern Cone, and the Episcopal Diocese of Fort Worth does hereby immediately enter into membership with the Anglican Province of the Southern Cone as a full and equal constituent member of such province, and the Episcopal Diocese of Fort Worth does hereby accede to the authority of the Constitution and Canons of the Anglican Province of the Southern Cone to the extent such Constitution and Canons are not contrary to Holy Scripture and the teaching of the one holy, catholic and apostolic Church.

Proposed by the Committee on Constitution and Canons

Explanation:

The Episcopal Diocese of Fort Worth has resolved to remain within the family of the Anglican Communion while dissociating itself from the moral, theological, and disciplinary innovations of The Episcopal Church in the United States of America. The Synod of the Anglican Province of the Southern Cone, meeting Nov. 5-7, 2007, voted to welcome into membership of their Province those dioceses of The Episcopal Church in the United States of America who share this resolve.

Therefore the Episcopal Diocese of Fort Worth, acting by and through its lawfully constituted convention of clergy and lay delegates, proposes to enter into affiliation with the Anglican Province of the Southern Cone.





The Episcopal Diocese of Fort Worth · As We Realign

Our 26th annual convention has taken action to secure our future as a diocese.

During the Nov. 14 & 15 diocesan convention, your clergy and elected delegates have taken a stand as faithful members of the worldwide Anglican Communion. They have heeded the call to "contend for the faith that was once for all entrusted to the saints." (Jude 3)

What has changed?

By voting to change our diocesan Constitution and Canons, we have withdrawn from the General Convention, dissociating ourselves from the moral, theological, and disciplinary innovations of The Episcopal Church. We have realigned with another Province of the Anglican Communion. This is a change in affiliation, not a change in worship or doctrine.

Our Bishop, clergy, and congregations have been received into the fellowship of the Anglican Province of the Southern Cone. We are deeply grateful to Archbishop Gregory Venables for this provision, which he has made on a temporary and emergency basis, in response to the crisis in The Episcopal Church. We now look forward to the formation of an Anglican Province in North America.

Where we stand.

We remain true to the historic faith and order of the Church.

We remain a member diocese of the Anglican Communion.

We remain the Episcopal Diocese of Fort Worth. The word "episcopal" identifies us as part of the apostolic succession, with a bishop as our elected chief pastor.

We remain in communion with other Episcopalians. We share fellowship with all those in any Province who recognize the authority of Scripture and the faith and order of historic Anglicanism.

Everyone is welcome to worship in our churches this Sunday and every Sunday. Our liturgy remains the same, our name is the same. Most of all, we remain committed to the Gospel of our Lord and Savior Jesus Christ.



What is the status of our clergy?

Our clergy continue to be licensed for ministry by Bishop Iker. TEC benefit programs, which may no longer be available to them, have been replaced by new group insurance policies and a retirement plan. Clergy who have established pension accounts in TEC will be eligible at retirement to receive benefits earned. While these will be less than they might have had by staying with the program longer, their new investment plan will provide supplemental retirement funds.

What about those Episcopalians who disagree with the decision to realign?

We know that not everyone agrees with this change. Those who dissent are valued brothers and sisters in Christ, and they are welcome to remain in their congregations. For some, however, it may be necessary to separate from the diocese, perhaps permanently. In a few cases, it may be the will of a majority of the members in a particular parish to remain in The Episcopal Church. Where this is the case, the Bishop, Standing Committee, and Board of Trustees hope to work with the rector and vestry to come to a mutually agreeable separation and settlement of property issues without resort to lawsuits or other hostile actions.

What response should we expect from representatives of the General Convention?

We expect a number of announcements in the days, weeks, and months ahead. Among these may be plans for a new General Convention-member diocese in this 24-county area. There may be lawsuits testing the ownership of our properties. And action may be taken to remove our Bishop and clergy from their positions in ministry in the General Convention church. But such action will have no practical effect, since they will already be ministering under the authority of another Anglican Province. These developments may generate news headlines, and they may cause some confusion, but they will not prevent us from going forward in mission as a diocese.

What next?

On Nov. 24, Bishop Iker will meet with the clergy on the topic of "Moving Forward – Life After TEC." Other events for clergy and lay people will be announced in the weeks ahead. Please continue to pray for our diocese, for all Episcopalians, and for the Church throughout the world. Let us pray for God's guidance for ourselves and for the leadership of our churches and diocese. Let us seek the peace that passes understanding. Let us rejoice in God's saving grace and continue to carry his message of love and salvation to the world.



The actions of our 26th diocesan convention assure us of our future as traditional Anglicans. We are now free to carry out our diocesan mission, "To equip the saints for the work of ministry."

RESPONSES TO ATTEMPTED INHIBITION OF THE BISHOP

FORT WORTH, Texas – A letter of inhibition and supporting documents were issued Friday, Nov. 21, from the office of Katharine Jefferts Schori, Presiding Bishop of The Episcopal Church, to the Rt. Rev. Jack Leo Iker, Bishop of Fort Worth. However the inhibition is of no force or effect, since the Bishop and Diocese, meeting in annual convention, constitutionally realigned with another province of the Anglican Communion on Saturday, Nov. 15, and are now constituent members of the Anglican Province of the Southern Cone. Documents to this effect have been made public. Consequently, this attempted inhibition will not deter the Bishop from the continuance of his ministry.

Two responses are being issued at this time. From Bishop Iker:

Katharine Jefferts Schori has no authority over me or my ministry as a Bishop in the Church of God. She never has, and she never will.

Since November 15, 2008, both the Episcopal Diocese of Fort Worth and I as the Diocesan Bishop have been members of the Anglican Province of the Southern Cone. As a result, canonical declarations of the Presiding Bishop of The Episcopal Church pertaining to us are irrelevant and of no consequence.

The Rt. Rev. Jack Leo Iker Bishop of Fort Worth

From the Standing Committee:

The Standing Committee of the Episcopal Diocese of Fort Worth is a member of the Province of the Southern Cone as of November 15, 2008. Bishop Iker is a member in good standing of the House of Bishops of the Province of the Southern Cone.

We wonder by what authority the Presiding Bishop of the Episcopal Church in the United States presumes to inhibit a bishop of the Province of the Southern Cone. We do not recognize



the authority of the Presiding Bishop over us. We regret this illegal, unconstitutional, and uncanonical attempt to interfere with the rights and ministry of a diocese of another province of the Anglican Communion. We call upon her to desist from any further actions in our diocese and that she refrain from any further border crossing.

An Appeal from the Bishop for the LEGAL DEFENSE FUND

Dear Faithful Parishioners,

It is time for every loyal parishioner in the Diocese to step forward and make a contribution to our Legal Defense Fund. Every gift matters – every donation is important! Our goal is to raise a minimum of \$1 million to cover our legal fees as a result of the litigation brought against us by The Episcopal Church and its local supporters. At stake is everything we have as a Diocese – ownership of Camp Crucis and the Diocesan Center, our churches and property, our bank accounts and investments, our clergy and our Bishop. TEC wants it all!

As you know, by a margin of 80% our 2008 Diocesan Convention voted to remove all references to The Episcopal Church from our Constitution and Canons. TEC was formed as a voluntary association, and it remains so today. A diocese can withdraw from TEC by a Convention vote, just as it joined TEC by a Convention vote. However, the minority group who disagreed with this decision claimed that we did not have the legal right to do so and declared that all our church property actually belongs to TEC. They held a bogus meeting in 2009 where they attempted to replace all the legitimate officers of the Diocese and the Corporation of the Diocese, and they later declared all our clergy were deposed from the ordained ministry. It is this bogus group of representatives who have sued us, the real Diocese and the real Corporation, demanding that we turn over all our property and assets to them!

While this fairy tale may have initially confused the Tarrant County trial court, the Appellate Court was not confused and ruled on June 25th that these individuals could not sue us in the name of the Diocese and of the Corporation, but only as individuals. They have now refiled their suit in their own names. In the end, we are confident that the Texas courts will enforce our state laws governing corporations and property ownership.

In addition, we have been dragged into a second court case (this one in Hood County) where TEC supporters are trying to prevent St. Andrew's Episcopal Church in Fort Worth from receiving funds left to them in a bequest by a parishioner. TEC wants the money sent to them instead!

I am saddened by the necessity of having to defend ourselves in these lawsuits. We did not initiate this litigation, and in fact, we have done everything we could to avoid it. From the beginning, we asked the disenchanted minority to join us in developing a reasonable plan to divide the property and assets of the Diocese so that we all could continue to carry on God's work without the distractions created by litigation. In fact, the Corporation deeded their church property to Trinity Church in Fort Worth, St. Luke's in Stephenville, and St. Martin's in Keller, because these parishes wished to remain in TEC. We were in the process of doing the same for others when TEC

filed suit against us, demanding all of our property. The Presiding Bishop of TEC has insisted that TEC must have ALL of the assets and property of our Diocese. Given that position, we have had no alternative but to engage legal counsel to protect our interests and to bring this process to an end at the earliest possible time.

It is the strategy of TEC in all of its litigation to make it as expensive as possible for those it sues, so that they either give up or are unable to continue the process of litigation. The only way we have been able to defend our congregations in court so far is through the generous support of Dick and Marsland Moncrief. To date the Moncriefs and a few others have contributed about \$900,000 to our defense, and the litigation costs continue! I feel the time has now come for our legal fees to be shared by all concerned members of this diocese, not just a few, and for that reason I am asking for your support.

Please consider making a special gift to this fund, which will qualify as a tax-deductible charitable donation to the Diocese. Though one-time gifts are great, it would help if you could pledge a certain amount over a period of several weeks or months. With your help, we are optimistic about our goal of securing our legal position as a diocese, but it is a very expensive process. In the event that our funds are not exhausted before litigation ends, the balance will be directed toward the mission of the Church.

Thank you for considering this need. Do uphold this whole campaign in your prayers!

Questions and Answers about the litigation

How did this controversy end up in court? Aren't Christians supposed to be able to solve their differences without resorting to lawsuits?

We are in court as defendants, in a suit brought against us by The Episcopal Church and their local supporters. Yes, we offered out-of-court settlements and even deeded church property to them, but this was not acceptable to the other side. They don't want just what's theirs - they want what's ours as well!

What's at stake if we lose in the courts?

All church property and assets would be placed under the control of TEC. Our clergy and Bishop would be removed from the churches and replaced by TEC loyalists. Only those who swore allegiance to the revisionist doctrines and practices of TEC could hold any office. Finally, they would need to sell some of the property they acquired in order to recover their own legal expenses.

Questions and Answers, cont.

How much has this lawsuit cost us, and how much more it is likely to require?

Since the litigation was filed against us in April 2009, we have spent close to \$1 million in attorney fees. Considering that the case will likely end up before the Texas Supreme Court, even with our attorneys

reducing their hourly rates as low as possible, we can anticipate at least an additional \$1 million to see it through to a conclusion. With roughly 8,000 households in the diocese, this amount could be raised through individual contributions of \$125 per family, at a rate of \$25 per month over five months.

The chart at right breaks down the

\$1 million goal, showing average pledges needed depending on the number of participating households. If each household contributes as it is able, the goal can be reached in a timely way.

Who has paid the bills for all this?

Dick and Marsland Moncrief have stepped forward and paid nearly all of this, but this one family should not be expected to bear the entire burden for the rest of us! Every parishioner should help bear some of this load, and that is why we have launched this Legal Defense Fund Appeal. It is our battle, not someone else's!

Be assured that no funds have come from church assessments or the diocesan budget. The mission work of the diocese continues. While we have made cuts in spending as these challenging economic times have demanded, we have not done so to divert funds for litigation.

How many people support the TEC position, and how many stand with Bishop Iker?

It is roughly a 20/80 split. The convention delegates who voted to separate from TEC in 2008, the number of congregations aligning with Bishop Iker, and the average Sunday attendance of those remaining with the diocese since the split are a solid 80% of the total.

Why should we give money for lawyer fees, when we would rather support the ministry of the Church?

The lawyers we have hired are devout Christians who see the battle we are engaged in as spiritual warfare. Defending the truth of the historic faith and practice of the Church is part of our ministry as a diocese. Our legal team is attempting to protect our churches from a hostile takeover, and their fees are well below the normal attorney fees. No lawyer gets rich on court cases involving church controversies. Without this representation, we would be overwhelmed by the other side. Our attorneys believe in what we are standing up for as Christians, and they deserve fair compensation for their services. They see their professional work as part of their ministry.

How can we learn more?

Litigation Perspective

FROM OUR LEAD ATTORNEY, J. SHELBY SHARPE

The litigation that The Episcopal Church has filed in Tarrant County and Hood County needs to be put in proper perspective for your understanding and to obtain a sense of peace in your heart.

Keep these thoughts in mind as you pray:

- First, the litigation is contrary to 1 Corinthians 6: 1-7. Thus, God is not the author of the suit although He has allowed it to happen.
- Second, the response to the suit by your leaders is based on sound law that, if followed by the court, should result in a defeat for those bringing the litigation.
- Third, The Episcopal Church is asking for property that it did not buy nor does it have any legal or ecclesiastical right to receive.
- Fourth, your leaders who have been sued have conducted themselves in accordance with law, pertinent ecclesiastical documents, and the Scriptures.
- Fifth, the response of your leaders seeks no relief from the court that is contrary to any Scripture.
- Sixth, the response of your leaders to those suing them will be made in a Christ-honoring manner, whether in or out of court.
- Seventh, pray for those representing your leaders that God will lead and guide them so that He is glorified in all that is done.
- Eighth, pray for the leaders of The Episcopal Church and the others who have brought the suit that they will hear and obey what God would have them do.
- Ninth, pray that your leaders and all who support them will be a good testimony to those who do not know the Lord who are watching the litigation so these lost people will not be discouraged from seeking Jesus. This includes speaking no evil of those who have brought the suit.
- Tenth, pray for each court before whom the suit goes, that God will protect each from any influence other than His, and that justice will be the basis for every ruling.

Churches helping families through hard times

On Thursdays the food comes in. On Tuesdays it goes out again. Week in, week out, that has been the routine at Christ the King, Fort Worth, for a dozen years or more. The church's food bank ministry is housed in a portable building on the west side of the parking lot, walking distance from the bus stops on Camp Bowie Blvd.

The parish-run ministry is powered by the time,

talents, and treasure of the congregation, but principally by Andy and Judy Perrier, who have made it their labor of love.

About 2,000 pounds of food are purchased each month. Selections are made from a shopping list provided by the Tarrant Area Food Bank. Name-brand items are purchased

at bargain prices, and the selections are stored on shelves and in refrigerators till distribution day. Fr. Jon Jenkins, rector of Christ the King, says the whole program cost only about \$2,500 in 2008.

An air of calm pervades the workroom, and the team takes an interest in each family it serves. A retired couple may be offe red some coffee creamer; a young mother may come away with a treat for her children's school lunch bags.

"I never knew you were here," says one first-time visitor whose husband had his hours cut back at work. On a recent Tuesday, three of the first 11 families served were new to the food pantry.

Demand for hot meals and grocery assistance is growing in many areas of the diocese. Since September, St. Mark's, Arlington, has operated a soup kitchen every Thursday at lunchtime. (For more about this, see furpiscopal.org.)

St. Simon's Church in southeast Fort Worth has been a leader in the cooperative SEARCH (South East Area Churches) ministry for 15 years. The church has been the ministry's No. 1 donor for 12 of those years, contributing cash and grocery items every week, plus family-sized food baskets at Thanksgiving and other gifts at Christmas and Easter. A member of the parish currently serves as president of the SEARCH board. "The needs

From the Bishop

God's great surprise

by the Rt. Rev. Jack L. Iker, Bishop of Fort Worth

Have you ever stopped to think what a huge surprise that first Easter Day was to the friends of Jesus? The women going to the tomb early that morning certainly didn't expect to find it empty! They had gone to anoint a dead body, not to witness a resurrection. They had not expected to see the stone rolled away and the body of Jesus miss-

ing from his grave. The Gospel writers describe them as astonished and amazed. At first they failed to understand what had happened, thinking perhaps that someone had come during the night and stolen the crucified body of Jesus.

And as for his other disciples – Peter, James, John and the others – where were they? They had not hurried out to the tomb that Easter morning expecting to see that Jesus had risen from the dead. No, they were still in hiding, paralyzed by grief and fear, behind the locked

doors in an upstairs room of a friend's house. When the women came and told them that the body of Jesus was not in his tom b, they didn't say, "Oh, yes, we thought this might happen. We expected Jesus might rise from the dead." No, they were surprised and bewildered, just like the women, and they could hardly believe it. So Peter and John jumped up and ran to the tomb, finding it just as the women had said. It was only later,

when the risen Jesus came seeking them back in the upper room, that they understood and believed.

Easter was God's great surprise to those first Christians, and it remains the miraculous act of God that is the sure foundation of our faith. Because Jesus is truly risen from the dead, we know

that we too are raised with him to eternal life, by his grace and power.

Is there room in your faith for God to surprise you? Is there room for a God who raises the dead and heals the sick and answers prayer? Our problem is not that we expect too much of God, but that we expect too little. But the message of Easter is that our God does miraculous things and brings new life in ways that we do not expect. He is the God who liberates and delivers us from sin and death and gives us

hope for the future. All is not lost, even when things may look rather dismal and bleak. Look to God through the lens of the Easter faith and expect him to surprise you in ways you may not expect.

Invite the light of the risen Jesus to dispel your worries, fears and resentments, that you may know the joy and triumph of resurrection life even now.



New congregations active in worship, ministry

With six new congregations added to the diocese in the closing weeks of 2009, Bishop Iker has begun making his first episcopal visitation to each.

During Advent the Bishop visited the diocesan church plant of Christ the Redeemer in Fort Worth, confirming or receiving 13 members.

Some of those joining the mission church, which meets at the Lockheed Martin Recreation Area, have transferred from other area churches; others are new to the Anglican tradition. Christ the Redeemer began weekly services just six months ago, in August 2009, and is averaging one baptism a month! Fr. Christopher Culpepper is vicar, their Web site is www.ctrfw.org.

On Jan. 23, the Bishop and Canon Charles Hough joined Fr. Darryl Pigeon and Fr. Randall Foster in Waco for a wellattended Saturday afternoon service of

confirmation. The congregation, which has taken the name King of Glory, was organized by friends Jeff Wallace and Jeff Fish, who paid a visit to



coming to our church?"

The congregation of St. Gabriel's in Springdale, Ark., hosted an ecumenical Evening Prayer service on Friday, Feb. 5. The community event was held to raise funds for the relief of earthquake victims;

its theme was "Have a Heart for Haiti." Fr. John Slavin represented the Anglican tradition, while priests from the local Roman Catholic and Antiochian Orthodox churches joined him as worship leaders, bringing together the



three great strains of Christianity. Reporting on the service, the local newspaper called them "cousins" who "came together for a common cause." (As it happened, all three priests were named John!) From the Bishop

A season of repentance and forgiveness

by the Rt. Rev. Jack L. Iker, Bishop of Fort Worth

The Pharisee stood and prayed thus with himself, "God, I thank thee that I am not like other men, extortioners, unjust, adulteers, or even like this tax collector. I fast twice a week, I give tithes of all that I get." But the tax collector, standing far off, would not even lift up his eyes to heaven, but beat his breast, saying, "God be merciful to me a sinner!" (Luke 18:11-13)

Lent is a penitential season of fasting, prayer and self-denial. Our emphasis for these 40 days is upon repentance and forgiveness. We are called to recognize and confess our sins, to ask God's forgiveness and mercy, and to pray for grace to amend our lives according to His will. It means being changed by a daily pattern of repentance, forgiveness and amendment of life.

In our Lord's parable of the Pharisee and the tax collector (Luke 18:9-14) Jesus contrasts two very different spiritual attitudes in our relationship with God. The first is one of pride, self-righteousness, and superiority. The Pharisee reminds God that he is a good and pious man, better than others. The tax collector, on the other hand, knows he is a sinful man, undeserving of God's forgiveness and love. In sadness and humility, he throws himself upon the mercy of the Lord. Jesus concludes with a central teaching that runs throughout the entire Bible: "Everyone who exalts himself will be humbled, but he who humbles himself will be exalted." (verse 14)

Lent is a time to grow in humility. First, it requires daily self-examination and confession, as we acknowledge our faults and failures before God. Second, it requires contrition, an expression of our sorrow for the things we have done and left undone. Then we resolve to do better, as we ask for God's strength and help to amend our lives, and we offer ourselves as channels of His love and forgiveness in our interactions with others.

Several times a day throughout this Lent, make a habit of repeating an ancient prayer that comes to us from the Eastern Orthodox tradition called the Jesus Prayer:

Lord Jesus Christ, Son of the living God, have mercy upon me a sinner. Lord Jesus Christ, Son of the living God, have mercy upon me a sinner. Lord Jesus Christ ...

NATURE OF ORGANIZATION AND SIGNIFICANT ACCOUNTING POLICIES

ORGANIZATION

The Episcopal Diocese of Fort Worth (the Diocese), was organized in January of 1983 under the Constitution and Canons of the Episcopal Church U.S.A. The Bishop of the Diocese has jurisdiction over all organizations within the Diocese. These include parishes, missions, schools, hospitals, other certain charitable organizations and funds. Title to all property of these organizations is in the name of the Corporation of the Episcopal Diocese of Fort Worth.

The accompanying financial statements include accounts maintained by the Finance Committee of the Diocese. These accounts include general operations of the Diocese, loans made to related organizations, and special donor restricted accounts and pass-through accounts.

The Corporation of the Episcopal Diocese of Fort Worth holds substantial amounts of real estate intended for use in Diocesan activities. Such real estate held by the Corporation is not included in the accompanying financial statements.

BASIS OF ACCOUNTING

The financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

FINANCIAL STATEMENT PRESENTATION

The Diocese has adopted Statement of Financial Accounting Standards (SFAS) No. 117, "Financial Statements of Not-for-Profit Organizations." Under SFAS No. 117, the Diocese is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted, temporarily restricted, and permanently restricted. In addition, the Diocese is required to present a statement of cash flows. The Diocese has discontinued its use of fund accounting.

CONTRIBUTIONS

The Diocese has also adopted SFAS No. 116, "Accounting for Contributions Received and Contributions Made." whereby contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support depending on the existence and/or nature of any donor restrictions. Restricted net assets are reclassified to unrestricted net assets upon satisfaction of the time or purpose restrictions.

NATURE OF ORGANIZATION AND SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

INCOME TAX STATUS

The Diocese is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code.

STATEMENT OF CASH FLOWS

For purposes of the Statement of Cash Flows, cash and cash equivalents include all highly liquid investments with original maturities of three months or less.

NET ASSETS RELEASED FROM RESTRICTIONS

Net assets were released from donor restrictions by incurring expenses satisfying the restricted purposes or by occurrence of other events specified by donors during 2006. The total amount released for 2006 was \$428,935.

RETIREMENT PLAN

The Diocese contributes to a retirement plan for eligible lay employees that is maintained by a national Episcopal agency. Episcopal Clergy are covered through the Church Pension Fund. Contributions are determined by salaries and length of service. The total expended for pension benefits in 2006 was \$148,418.

CONCENTRATION OF CREDIT RISK FOR CASH AND CASH EQUIVALENTS HELD IN FINANCIAL INSTITUTIONS

The Diocese maintains cash balances in excess of \$100,000 in banks, which are insured by the Federal Deposit Insurance Corporation up to \$100,000. At December 31, 2006, the Diocese's uninsured cash balances totaled \$726,658.



In November 2008, the convention of the Episcopal Diocese of Fort Worth took certain actions intended to disaffiliate the diocese from the Episcopal Church, something not contemplated in the canons, the expected culmination of over a decade of maneuvering to enable the diocesan structures to retain control of real estate and other material assets after the putative disaffiliation. Around eighty per cent of the clergy of the diocese supported those actions, as did a similar percentage of the lay delegates to the convention. Litigation is in progress.

In February 2009, the Presiding Bishop chaired a special convention to begin the work of reorganization, restoration and reconnection. That convention elected a provisional bishop and other officers required by canon and moved as well to begin repopulating the various diocesan agencies, commissions, committees, and other working bodies. The people who stepped up to those responsibilities discovered quite soon that their work would be doubly arduous, simply because their predecessors in office—all but one of whom were part of the movement to disaffiliate—kept all the records, indeed have them still.

For that reason, collecting the information for this journal has been in many cases rather an *ad hoc* operation. I am glad to say that I have enjoyed superb cooperation from everyone—from the provisional bishops right down through parish officers—which is doubly gratifying considering how most of them were finding their way just as warily as I was.

This journal includes minutes from both the special meeting of convention in February 2009 and the regular annual convention in November that year. It contains as well as much of the information ordinarily included in diocesan journals as (1) I have been able to identify as required or expected (this is the first journal I have been responsible for) and (2) as my colleagues around the diocese have been able to round up. I am confident that subsequent journals will include more information and present it in ways that make it useful to people who use it for planning or other purposes. I will be grateful for your suggestions for improvement.

I want to name two people in particular and thank them for their help. The Rev'd. John A. Logan, Jr, Secretary of the Diocese of Texas, responded to my plea for guidance and got me started, and I am grateful. To Mrs. Joan McCauley, parish secretary at St. Christopher's Church in Fort Worth, fell the job of helping me assemble the various materials in the plethora of formats they came in and turn it all into something useful. One hesitates to use a cliché—but I quite literally could not have done it without her.

Minutes

Before the business meeting, the convention offered the Holy Eucharist at All Saints' Church on which occasion the Presiding Bishop, the Most Rev. Katharine Jefferts-Schori was principal celebrant and preacher.

The Presiding Bishop called the special meeting to order at 1:40 P.M. and, after leading prayer, reminded the convention that when in a diocese there is neither sitting bishop nor standing committee, as was the situation that day, the canons of the Episcopal Church require the presiding bishop to consult with members of the diocese to provide episcopal ministry and to elect qualified persons to other required canonical functions.

Walt Cabe, Chair of Dispatch of Business, presented the agenda (in the hands of all delegates) and moved its adoption, the motion seconded by many. Motion carried unanimously.

The Rev. J. Frederick Barber, Rector of Trinity Church, welcomed the convention on behalf of the parish vestry.

Mr. Cabe introduced and welcomed the following visitors:

Mr. Cabe further thanked the members of the team that has worked with the Presiding Bishop to respond to the situation in the Diocese of Fort Worth: Bishop Gulick, Bishop Clay Matthews, Canon Cluett, the Rev. Robert Allen, David Beers, Mary Kostel. He also thanked Trinity Church, its rector, wardens, and vestry, for the parish's hospitality during the months leading up to the convention.

The Presiding Bishop noted that the rules of order and other standing rules for the convention were posted on the diocesan website and proposed their adoption without reading. A motion to adopt, made and seconded from the floor, carried unanimously.

As its chair, Fr. Moore gave the Credentials Committee's first report. Of twenty-three (23) diocesan clergy qualified to vote, nineteen (19) were present. Of the fifty-five (55) congregations in the diocese, thirty-one (31) had either a delegation or a delegate present with a total of sixty-two (62) voting delegates on the floor. Therefore a quorum was present.

The Presiding Bishop invited a motion to give voice but not vote to the Rev. John Keene, the Rev. James Horton, and the Rev. Maureen Lewis. The motion made and seconded from the floor carried unanimously.

The chair recognized Fr. Moore who **nominated** the Rt. Rev. Edwin Gulick, Bishop of Kentucky, to be Provisional Bishop of the Diocese of Fort Worth. Numerous **seconds** came from the floor. The Presiding Bishop asked for further nominations but hearing none asked for a motion to close nominations. The **motion** made and seconded from the floor **carried unanimously**.

The Presiding Bishop spoke of her gratitude to Bishop Gulick and the Diocese of Kentucky for acceding to her request for assistance.

Fr. Taylor explained that the vote on the nomination of Bishop Gulick would be a voice vote by orders. He called for the clergy vote, which was unanimously in favor. He called for the lay vote which was unanimously in favor except for one abstention. The Presiding Bishop noted that the "all but universal consent" by voice vote far exceeded the canonical requirement of two-thirds consent in both orders and declared the election done and Bishop Gulick elected.

The convention's work then stopped momentarily while the Presiding Bishop installed Bishop Gulick as Provisional Bishop of the Episcopal Diocese of Fort Worth.

Bishop Gulick spoke of his gratitude to Bishop Katharine and to the convention and standing committee of the Diocese of Kentucky. He thanked especially Mrs. Gulick for her patience and commitment to this enterprise.

Fr. Madison, Chair of Resolutions, moved that the convention suspend any and all time deadlines which would prevent the convention considering the committee's report. Upon second, motion carried unanimously.

Fr. Madison asked if, other than himself or the Rev. Chris Jambor, any person who claimed to hold some office in the Diocese of Fort Worth were present. Delegate Henning noted that he is a Trustee of the University of the South.

Fr Madison moved the adoption of Resolution #5, towit:

A RESOLUTION REGARDING VACANCIES IN DIOCESAN OFFICES AND PROCEDURES TO FILL VACANCIES

WHEREAS as a result of the actions taken at the November 15, 2008 Annual Convention of the Diocese, a significant number of diocesan leaders, both lay and clergy, left the Episcopal Church and its Diocese of Fort Worth and claim to have become members of the Anglican Province of the Southern Cone; and

WHEREAS on December 5, 2008 the Presiding Bishop of the Episcopal Church accepted the renunciation by the former bishop, the Rt.. Rev. Jack L. Iker, of his ministry in the Episcopal Church; and

WHEREAS the Presiding Bishop declared that the members of the standing committee of the diocese were no longer qualified to serve on the diocesan standing committee as they had left the Episcopal Church; and

WHEREAS other diocesan officers who were elected or appointed to their positions on November 14-15, 2008, or whose terms of office extended past November 15, 2008, also left the Episcopal Church on or about November 15, 2008; and

WHEREAS the Convention is aware only that Fr. Christopher Jambor, elected October 23, 2008 from the West Fort Worth deanery as a clerical member of the executive council, and Fr. David Madison, elected at the annual convention on November 17, 2007 to the ecclesiastical court, still hold diocesan offices and have remained in the Episcopal Church; and

WHEREAS despite extensive notice and publicity before and after November 15, 2008, including work by the Steering Committee North Texas Episcopalians, about how the remaining Episcopalians in the diocese planned to reorganize the diocese, including the convening of this special meeting of Convention to fill vacant diocesan offices; and

WHEREAS despite numerous opportunities after November 15, 2008 for diocesan officials to make known their intention to remain in the Episcopal Church, and further despite the inquiry being made publicly during this special meeting, the members of the Convention have not received word that any diocesan official, other than the two

officers mentioned above, were still members of the Episcopal Church and would continue to serve in diocesan offices after November 15, 2008; and

WHEREAS the procedures provided by the diocesan constitution and canons to fill those positions so vacated by former diocesan leaders are impossible to comply with, because the diocese has no bishop or standing committee, its annual convention cannot be convened until November 2009, and in some instances no remaining members serving on a board, or because the diocese is otherwise burdened by the extraordinary circumstances created by the decisions made at the 26th diocesan convention in 2008 and consequent abandonment of the Episcopal Church and its Diocese of Fort Worth by diocesan leaders; and

WHEREAS under these extraordinary circumstances strict application of the provisions of the diocesan constitution and canons regarding filling vacant diocesan offices would paralyze the diocese and work an injustice, contrary to the intention and purpose of the constitution and canons; and

WHEREAS it is in the best interest of the Episcopal Church and its continuing Diocese of Fort Worth for the diocese to declare certain offices vacant and to expeditiously select and install qualified officials to fill the offices vacated by those who have left the Episcopal Church so that the work and mission of the diocese may proceed in the months proceeding its annual convention in November 2009.

BE IT THEREFORE RESOLVED that, in addition to those offices previously declared vacant by the Presiding Bishop, the following diocesan offices be and are hereby declared to be vacant:

BE IT FURTHER RESOLVED that, to the extent it is impossible to comply with the procedures established by the constitution or canons or other applicable authority to fill the vacancies in these offices, the Convention finds that the procedures used to fill those vacancies at this special meeting of the Convention be and are hereby declared to be valid.

Upon second from the floor and discussion called for, motion carried unanimously.

Fr. Madison explained and moved the adoption of Resolution #1, originating in the Constitution and Canons Committee, towit:

A Resolution Declaring Null and Void Certain Provisions of Diocesan Constitution and Canons and Resolutions

WHEREAS some of the former leadership of the Diocese of Fort Worth embarked on a plan to leave the Episcopal Church and purportedly for the diocese to dissolve its affiliation with the Episcopal Church; and

WHEREAS in a series of annual diocesan conventions steps were taken by diocesan leadership to modify the diocesan constitution and canons in furtherance of that plan, and in 2007 and 2008 a majority of the delegates voted in favor of certain changes to the diocesan constitution and canons and passed a resolution, all in an attempt to effect their plan to leave the Episcopal Church; and

WHEREAS certain of those actions are null and void on their face because they are in contravention of the constitution and/or canons of the Episcopal Church and/or applicable law and thus are unenforceable, including but not limited to the attempted unilateral disassociation of the diocese itself from the Episcopal Church, a continuing claim of former diocesan leadership to church property in the diocese, and an attempted affiliation of the diocese with the Anglican Province of the Southern Cone; and

WHEREAS at this special meeting of Convention the need exists to immediately declare those actions to be unenforceable until such time as those governing documents can be formally amended to bring them into conformity with the constitution and canons of the Episcopal Church, as provided in the diocesan constitution and canons, beginning at the next annual diocesan convention in 2009.

BE IT THEREFORE RESOLVED that the following provisions of the diocesan constitution, canons, and resolutions approved at the previous annual diocesan conventions be and are declared to be null and void and unenforceable:

She in turn presented to the Presiding Bishop a card with "a representative sampling" of signatures and expressions of gratitude, original works of art by Fort Worth artist Shawn Reese, and a poem by Deborah Hudson, who read the work.

Fr. Stanford rose to thank Mrs. Gulick for "lending" her husband to the Diocese of Fort Worth. The bishop asked his wife to stand in response to enthusiastic applause.

Fr. Pool suggested sending greetings in writing to the former bishops of the diocese, which action Bishop Gulick assured would be undertaken.

Fr. Taylor presented the second report of the elections committee. The following persons were elected to the office indicated.

In the election for Standing Committee, lay order, Prescott and Sherrod withdrew. In the election for Deputy to General Convention 2009, lay order, Fagley, Guinn, and Walker withdrew. In the election for Deputy to General Convention 2009, Coggin, Reeves, Reynolds, and Slaughter withdrew.

There being only a single candidate left for Standing Committee, lay order, Fr. Barber moved the election of Margaret Mieuli by acclamation. After second from the floor and clarification by the chancellor and parliamentarian, Bishop Gulick asked for the vote. Margaret Mieuli was elected unanimously.

After delegates marked ballots, Fr. Moore read a letter to the convention from Bonnie Anderson, President of the House of Deputies of the General Convention of the Episcopal Church, in which she assured the diocese of her prayers and support and welcomed the diocesan deputation to General Convention 2009.

After consultation with the chancellor and others, Bishop Gulick directed the elections committee to study the voting history in the elections for both lay and clerical deputies to General Convention 2009 and nominate an alternate or alternates in both orders, after which he would ask for a voice vote by orders to approve those nominations. To this direction the convention acceded.

Bishop Gulick announced that the annual diocesan convention will meet November 13 and 14, the location not yet settled.

Bishop Gulick recessed the convention for five minutes.

Upon resumption of business, Fr. Taylor presented the third report of the elections committee. The following person was elected to the office indicated.

 Deputy to General Convention 2009, clerical order: The Rev. David Madison

In the election for Deputy to General Convention 2009, lay order, Killingsworth, Minor, and Prescott withdrew.

Fr. Moore pointed out that since only fifty-two (52) lay ballots were cast, Susan Reeves was in fact **elected**, thus completing the election of lay deputies to General Convention 2009. Therefore:

Fr. Madison moved that Fr. Coggin and Deacon Nocher be elected alternate clerical deputy to General Convention 2009. Upon second from the floor, Bishop Gulick called for a voice vote by orders, both of which approved unanimously. Therefore:

All elections completed, Bishop Gulick adjourned the convention sine die at 5:30 P.M.

MINUTES

Actions of Friday, November 13, 2009

Bishop Gulick called the convention to order at 7:00 P.M. on Friday, November 13, at St. Christopher's Church and led the house in prayer.

Bishop Gulick thanked St. Christopher's for its hospitality on this and many other occasions during his service as provisional bishop; and he thanked the women of St. Alban, Arlington, for catering the reception for provisional bishop designate Ohl immediately before the convention opened.

The chair recognized the Rev. Courtland Moore, chair of the Credentials Committee, who reported that a quorum was present.

Bishop Gulick read a letter to the convention about the need to change certain unrepresented and unreorganized parishes to mission status to facilitate canonically consistent reorganization and asked the convention to refer his recommendation to the Standing Committee under the provisions of diocesan Canon 34.

"TO THE CLERGY AND DELEGATES OF THE DIOCESAN CONVENTION:

"You are all aware that, after the actions of former diocesan leaders on November 15, 2008, exigencies in governance still exist in certain congregations in the Diocese where the parish property remains under the adverse control of those who claim to have left The Episcopal Church. Under this adverse control these parishes have temporarily ceased to function as Episcopal parishes, and they are presently served by clergy under discipline which is in direct violation of the discipline of the Episcopal Church. The loyal Episcopalians remaining in these parishes have not yet been able to reorganize to elect a qualified vestry and to obtain clergy in good standing in The Episcopal Church in order to adequately protect the parish property and to continue the worship and mission of the parishes as part of The Episcopal Church.

"It is my opinion that changing these continuing parishes to mission status would enable the Bishop and the Diocese to assist more directly in their reorganization. Diocesan Canon 34 provides the procedure for the Annual Convention to change parishes to mission status for circumstances other than non-payment of assessment under Canon 16, as follows:

CANON 34

CHANGES OF PARISHES OR MISSIONS

Sec. 34.1 In circumstances other than non-payment of assessment and the consequences thereof described in Canon 16, whenever it shall appear to the Bishop that the conditions render it advisable to dissolve a Parish or Mission or to change a Parish to a Mission status, he shall submit the matter in writing to the next Annual Convention. The matter shall then be referred to the appropriate Committee on the first day of the Convention where it shall lay over until the following day. The Committee shall then report its recommendation in writing to the Convention. In order to declare the Parish or Mission dissolved or changed, a two-thirds (2/3) vote by orders shall be required.

"As a result I have determined that, pursuant to Diocesan Canon 34, conditions render it advisable to change the following parishes of the Diocese to mission status:

"Please note that this proposed change is not intended to be punitive or disparaging to any congregation in any way. Instead it is a pastoral attempt to recognize the unique reorganization struggles evident for each of these continuing Episcopal congregations and to enable the Diocese to provide more direct assistance to each congregation as needed for its governance, mission, and protection of real and personal property.

"This proposed action also would not establish a new congregation or dissolve any congregation. Instead it would merely change to mission status these continuing congregations that have in most cases been Episcopal parishes since long before 1983. I would anticipate that after a congregation has formally reorganized and again meets the requirements of a self-sustaining parish in The Episcopal Church, the Convention would eagerly reconsider changing the congregation's status back to parish status.

"Thus, pursuant to the requirements of Diocesan Canon 34, I am by this letter submitting the matter in writing to be considered by the Convention at its annual meeting

on November 13-14, 2009. I ask that this matter be referred to the appropriate committee on November 13, 2009, being the first day of the Convention, where it should lay over until the following day, and on November 14, 2009, for the committee to report its recommendation in writing to the Convention. It is my recommendation and hope that the Convention will declare that these parishes be changed from parish status to mission status."

Smith (All Saints', FW) moved, Fr. Gotcher seconded, that the convention refer the bishop's recommendation to the Standing Committee for appropriate action. Carried.

Bishop Gulick asked Constitution and Canons Committee chair George Komechak to review the committee's ongoing work to redress anomalies in the diocesan canons and bring them into compliance with national canons. After a thorough review, Komechak noted that two urgent matters remain unresolved.

- The question whether deacons may vote in convention or not, a matter under study by the Commission on Ministry. Komechak asked the convention's indulgence to postpone action until the 28th annual convention in 2010.
- Canon 43, the marriage canon. The diocese has never engaged in the listening process urged by General Convention. Rather than offer a rewritten canon now, the committee asks that the diocesan leadership implement *The Listening Process* suggested by Lambeth 1978/1988/2008, the Windsor Report in 2004, agreed to by several subsequent General Conventions, and posted on the Anglican Communion website.

The Rev. David Madison, chair of the Resolutions Committee, reviewed the resolutions coming before the convention the next day. He noted that three resolutions arising from the work of the Resolution 4 Committee (Special Convention Feb '09) could not be submitted by the deadline (twenty days before the date of convention) and asked the convention to suspend the pertinent rule to allow those resolutions to come before the convention the next day.

Fr. Stanford **moved**, Weidler (Trinity, FW) **seconded**, that the convention suspend Canon 2, Sec. 2.4 to permit the aforementioned resolutions to come to the convention floor the next day. Upon approval by a two-thirds majority, **carried**.

In the absence of the diocesan treasurer, Bishop Gulick asked Cherie Shipp (Trinity, FW, treasurer of the Corporation of the Episcopal Diocese of Fort Worth) to discuss the proposed diocesan budget.

Shipp reported that, due to numerous anomalies in the ways disrupted congregations have had to operate since the 26th Annual Convention, the budget is not yet sufficiently reliable for final approval. Fr. McClain reminded the convention of the February '09 Special Convention's urgency about meeting the diocese's obligations to the church-wide budget. Hicks (St. Christopher, FW) asked and got reassurance that the Executive Council has authority to amend the diocesan budget.

Fr. Taylor explained the election procedure, after which the tellers distributed ballots and the Convention voted.

The chair recognized Fr. Madison, chair of the Resolutions Committee.

Fr. Madison presented Resolution 1.

A RESOLUTION RATIFYING ACTION ADOPTING RESOLUTION 1 AT SPECIAL CONVENTION AND DECLARING NULL AND VOID CERTAIN PROVISIONS OF DIOCESAN CONSTITUTION AND CANONS AND RESOLUTIONS

WHEREAS some of the former leadership of the Episcopal Diocese of Fort Worth embarked on a plan to leave the Episcopal Church and purportedly for the diocese to dissolve its affiliation with the Episcopal Church; and

WHEREAS in a series of annual diocesan conventions steps were taken by diocesan leadership to modify the diocesan constitution and canons in furtherance of that plan, and in 2007 and 2008 a majority of the delegates voted in favor of certain changes to the diocesan constitution and canons and passed a resolution, all in an attempt to effect their plan to leave the Episcopal Church; and

WHEREAS certain of those actions are null and void on their face because they are in contravention of the constitution and/or canons of the Episcopal Church and/or applicable law and thus are unenforceable, including but not limited to the attempted unilateral disassociation of the diocese itself from the Episcopal Church, a continuing claim of former diocesan leadership to church property in the diocese, and an attempted affiliation of the diocese with the Anglican Province of the Southern Cone; and

WHEREAS at the special neeting of the Convention on February 7, 2009 the Convention adopted Resolution 1 and acknowledged that the need existed to immediately declare those actions to be unenforceable until such time as those governing documents can be formally amended to bring them into conformity with the constitution and canons of the Episcopal Church, as provided in the diocesan constitution and canons, beginning at the next annual diocesan convention in 2009; and

WHEREAS at this annual meeting of the Convention, which is the first annual meeting following the illegal actions taken at the November 15, 2008 annual meeting of the Convention and following the special meeting of the Convention on February 7, 2009, the Convention will be able to amend the canons under diocesan constitution [Article 18] to delete the illegal provisions of the canons to be effective upon adjournment of this meeting but will only be able to cast the first of two votes required under the diocesan constitution [Article 19] to amend the provisions of the constitution to delete the illegal provisions to be effective at the adjournment of the Convention's annual meeting in 2010; and

WHEREAS the Convention desires to reaffirm and ratify its action taken at the special meeting of Convention on February 7, 2009 in its adoption of Resolution 1 to declare certain provisions of the constitution, canons, and resolutions purportedly adopted as of November 15, 2008 to be null and void and unenforceable from their inception; and

WHEREAS the Convention further desires to declare that the illegal provisions of the constitution that cannot be formally amended until the annual meeting of the Convention in 2010 be declared null and void and unenforceable until they are formally amended;

BE IT THEREFORE RESOLVED that the Convention reaffirms and ratifies its action taken at the special meeting of Convention on February 7, 2009 in its adoption of Resolution 1 to declare the following certain provisions of the constitution, canons, and resolutions to be null and void and unenforceable from their inception; and

BE IT FURTHER RESOLVED that the Convention further declares that during the time between this annual meeting of Convention in 2009 and the annual meeting of Convention in 2010, the following illegal provisions of the constitution that cannot be formally amended until the annual meeting of the Convention in 2010 be and are hereby declared null and void and unenforceable until they are formally amended.

Fr. Madison moved, Fr. Pool seconded, adoption of Resolution 1. Carried unanimously.

Fr. Madison presented Resolution 2.

A RESOLUTION RATIFYING ACTIONS OF FEBRUARY 7, 2009 SPECIAL MEETING OF CONVENTION RETROACTIVELY

WHEREAS as a result of the actions taken at the November 15, 2008 annual convention of the diocese, a significant number of diocesan leaders, both lay and clergy, left the Episcopal Church and its Episcopal Diocese of Fort Worth and claim to have become members of the Anglican Province of the Southern Cone; and

WHEREAS on December 5, 2008 the Presiding Bishop of the Episcopal Church accepted the renunciation by the former bishop, the Rt. Rev. Jack L. Iker, of his ministry in the Episcopal Church; and

WHEREAS on December 15, 2008 the Presiding Bishop declared that the members of the standing committee of the diocese were no longer qualified to serve on the diocesan standing committee as they had left the Episcopal Church; and

WHEREAS because of the actions of former diocesan leaders the diocese was without a bishop, a standing committee, or other critical diocesan officials to continue the work of the diocese and the mission of the Episcopal Church; and

WHEREAS the Presiding Bishop called a special meeting of the Convention of the Episcopal Diocese of Fort Worth for February 7, 2009 to elect a provisional bishop and fill other vacancies in diocesan offices and take other actions necessary to reorganize the diocese; and

WHEREAS this annual meeting the Convention desires to ratify and confirm the calling of that special meeting, seating of delegates from the various congregations, and its actions taken at that special meeting, including but not limited to each of the resolutions adopted by the Convention and each election and appointment to fill vacant diocesan offices; and

WHEREAS despite extensive notice and publicity before and after the February 7, 2009 special meeting of convention regarding the reorganization of the diocese, including the filling of vacant diocesan offices and the continued mission of the Episcopal Church through its reorganized Episcopal Diocese of Fort Worth under the leadership of Bishop Edwin F. Gulick, Jr.; and further despite numerous opportunities after February 7, 2009, none of the former diocesan officials, whose positions were declared to be vacant and which positions were filled on or after February 7, 2009, have

made known to Bishop Edwin F. Gulick, Jr. or any other diocesan or church officials that the official was qualified to exercise and desired to exercise the duties of that office in the continuing, reorganized diocese because the official had not left the Episcopal Church and still was a member of the clergy or a lay member in good standing in the Episcopal Church and would conform to his or her ordination vows and/or meet the fiduciary duties required by Episcopal Church Canons in the continued work of the reorganized diocese; and

WHEREAS the procedures provided by the diocesan constitution and canons to call the special meeting of convention, select delegates from the various congregations in the diocese or to fill those diocesan positions so vacated by former diocesan leaders were impossible to comply with as a direct result of the actions of former diocesan leaders; and

WHEREAS the diocese was and remains otherwise burdened by the extraordinary circumstances created by the decisions made at the 26th Annual Convention in 2008 and consequent abandonment of the Episcopal Church and its Episcopal Diocese of Fort Worth by Diocesan leaders; and

WHEREAS under these extraordinary circumstances strict application of the provisions of the diocesan constitution and canons regarding filling vacant diocesan offices would have paralyzed the diocese and worked an injustice, contrary to the intention and purpose of the constitution and canons; and

WHEREAS it was and is in the best interest of the Episcopal Church and its continuing Episcopal Diocese of Fort Worth for the Convention of the diocese to have met in February 7, 2009 and to have declared certain offices to be vacant and to have expeditiously selected and installed qualified officials to fill the offices vacated by those who have left the Episcopal Church so that the work and mission of the diocese may have proceeded in the months proceeding this Annual Convention, which it has done;

BE IT THEREFORE RESOLVED that the Convention hereby declares that, in addition to those offices previously declared vacant by the Presiding Bishop, the offices filled by election or appointment on and after February 7, 2009, were in fact vacant on February 7, 2009, and the procedures for filling those vacancies are hereby ratified and regularized even if there were not technical compliance with the applicable governance provision in doing so.

IT IS FURTHER RESOLVED that the Convention hereby declares that each of the resolutions, elections, appointments, and other actions taken at the special meeting of convention, including but not limited to the call of the special meeting of convention, the selection and qualification of deputies from the various congregations in the diocese, and the filling of those diocesan positions so vacated by former diocesan leaders, be and are hereby declared to be ratified retroactively to February 7, 2009.

IT IS FURTHER RESOLVED that, to the extent it was impossible to comply with the procedures established by the constitution or canons or other applicable authority to fill the vacancies in these offices, the Convention finds that the procedures used to fill those vacancies at and after that special meeting of the convention be and are hereby declared to be valid.

Fr. Madison moved, Crews (St. Mary, Hillsboro) seconded, adoption of Resolution 2. Carried unanimously.

A RESOLUTION CONCERNING CHURCH PROPERTY AND LITIGATION

WHEREAS Episcopal Church Canon I.7.4 documents the existing trust interest of The Episcopal Church and its Episcopal Diocese of Fort Worth in all parish and mission property, real and personal, in the diocese; and

WHEREAS Canon I.7.4 conditionally grants limited authority and power to local parish and mission officials to use and control the property only "so long as the particular Parish, Mission or Congregation remains a part of, and subject to, this Church and its Constitution and Canons;" and

WHEREAS since at least November 15, 2008 the real and personal property, including dedicated and consecrated churches and chapels, funds, and records, of certain parishes and missions which, though they are still part of the Episcopal Church and this diocese, have been adversely held, used and controlled by those who claim not to be subject to the Episcopal Church and its constitution and canons and have permitted unauthorized use of the parish or mission property in violation of church and diocesan constitution and canons, including the conditional authority granted under Episcopal Church Canon I.7.4; and

WHEREAS such actions constitute a violation of the fiduciary duties imposed on church officials under Episcopal Church Canon I.17.8, and/or a violation of oaths of ordination to "conform to the Doctrine, Discipline, and Worship of The Episcopal Church" under Church Constitution Article VIII; and

WHEREAS despite ample opportunity since November 15, 2008, those persons have failed to acknowledge the authority of the Provisional Bishop and other officials of the diocese or of the Episcopal Church and failed to acknowledge the interest of the church and the diocese in the property;

BE IT THEREFORE RESOLVED that the Convention does hereby declare that as of on or about November 15, 2008 the real and personal property, including dedicated and consecrated churches and chapels, funds, and records, of the following parishes and missions of the diocese have not been held in compliance with the conditional grant of authority to parish and mission leaders to use and control the property under Episcopal Church Canon I.7.4.

BE IT FURTHER RESOLVED that the Convention declares that the persons who are adversely occupying, possessing, and controlling the above-referenced parish and mission property have no authority to do so.

BE IT FURTHER RESOLVED that the Convention ratifies and supports the efforts of Presiding Bishop Katharine Jefforts-Schori and Bishop Edwin F. Gulick, Jr. and other church and diocesan leaders for their stewardship and strong leadership to protect and enforce the interest of the Episcopal Church and the Episcopal Diocese of Fort Worth in, and to protect and recover possession of, the diocesan, parish and mission property for the mission, use, and benefit of the church and its diocese.

Fr. Madison moved, Cox (Trinity, FW) seconded, adoption of Resolution 3. Carried unanimously.

Fr. Madison presented Resolution 4.

A RESOLUTION CONCERNING THE PROVISIONAL BISHOP

WHEREAS the Rt. Rev. Edwin F. Gulick, Jr. has given notice of his intention to resign as Provisional Bishop of the Episcopal Diocese of Fort Worth (the "diocese"); and WHEREAS the standing committee of the diocese has consulted, pursuant to Canon III.13.1 of the General Convention of the Episcopal Church, with Presiding Bishop Katharine Jefferts Schori regarding continued placement of the diocese under the provisional charge and authority of a bishop of another diocese or of a resigned bishop, and recommends The Rt. Rev. _______ to serve as the second provisional bishop of the diocese and calls for his election;

BE IT THEREFORE RESOLVED that this Convention, regretfully but with gratitude for his exemplary service to the diocese and the church, accepts the resignation of the Rt. Rev. Edwin F. Gulick, Jr. as provisional bishop of the diocese, effective the date of his resignation.

BE IT FURTHER RESOLVED that, pursuant to Canon III.13.1 of the General Convention of the Episcopal Church, this Convention, in consultation with Presiding Bishop Katharine Jefferts Schori, places the diocese under the provisional charge and authority of the Rt. Rev. ______ (the "provisional bishop"), a resigned bishop in good standing with the Episcopal Church, to serve beginning the effective date of Bishop Gulick's resignation.

BE IT FURTHER RESOLVED that the provisional bishop, who shall serve with jurisdiction, shall be authorized to exercise all the duties and offices of bishop of the diocese until such time a bishop is elected and ordained for the diocese or until this action is revoked by this Convention.

BE IT FURTHER RESOLVED that the standing committee of the diocese shall be authorized to enter into an agreement with the provisional bishop providing for the compensation and benefits of the provisional bishop.

Upon Fr. Madison's request, Fr. Gotcher moved, McKneely (St. Stephen, Hurst) seconded, the Convention amend the resolution by eliminating the blank in paragraph #2 and inserting the name of the Rt. Rev. C. Wallis Ohl. Carried.

Upon Fr. Madison's request, Fr. Pool **moved**, Meeks (St. Simon, FW) **seconded**, the Convention amend the resolution by eliminating the blank in paragraph #4 and inserting the name of the Rt. Rev. C. Wallis Oh. **Carried**.

Fr. Madison moved, many seconded, the adoption of Resolution 4 as amended. Carried unanimously.

Fr. Madison asked to take up the Resolutions Committee's supplemental report. The Parliamentarian noted the need for a motion to depart from the agenda. At Bishop Gulick's suggestion, Fr. Stanford moved, Walker (St. Stephen, WFalls) seconded, the Convention take up the supplemental report at once. Carried.

Fr. Madison presented Resolution 5.

The chair recognized Deacon Sharla Marks to speak for the community of deacons within the diocese. She noted that two deacons—the Rev. Susan Slaughter and the Rev. ClayOla Gitane would soon be priested, leaving four deacons working in the diocese.

Deacon Marks asked the Convention to follow the deacons' lead in 2010 by connecting with schools public and private whose students come from low income families and offered assistance in contacting and dealing with school structures and setting up working relationships.

The chair recognized Jane McClain (St. Luke, Stephenville) who spoke of the Finance Committee's plans to offer leadership training tools for treasurers and other parish leaders, especially those without previous experience.

- A checklist for treasurers to assure compliance with both civil and ecclesiastical bookkeeping and reporting requirements
- A leadership training workshop scheduled for February 20, 2010, at All Saints Church, Fort Worth, led by Mr. Bob Schorr of the Diocese of Texas who regularly trains lay leadership in that diocese
- A nuts-and-bolts training session for treasurers in the late Spring, 2010

The chair recognized Fr. Barber to read a letter from the Presiding Bishop (see Appendix). Fr. Barber then **moved** "that this Convention of the Episcopal Diocese of Fort Worth accede to your wishes and the resolution of the Standing Committee of the Episcopal Diocese of Kentucky to release you from the obligations you assumed on our behalf when you were elected provisional bishop at the special convention on February 7, 2009." Upon **second** from the floor and the vote, the motion **carried unanimously**.

On behalf the Standing Committee, Fr. Barber then **nominated** the Rt. Rev. C. Wallis Ohl, retired Bishop of the Diocese of Northwest Texas, as the next provisional bishop of the Diocese of Fort Worth, to be effective upon his installation at the end of the Convention today. **Seconds** came from the floor. Bishop Gulick called for further nominations, and hearing none declared nominations closed.

Fr. Barber reported that the Standing Committee, in consultation with the Presiding Bishop as required by Episcopal Church Canon III.13.1, recommends the election of Bishop Ohl as our next provisional bishop.

After commenting on Bishop Ohl's fitness for the office, Bishop Gulick called for the vote by orders, and Bishop Ohl was **elected unanimously**. Immediately upon the election, the Convention paused while Bishop Gulick led the liturgy to install Bishop Ohl as Provisional Bishop of the Episcopal Diocese of Fort Worth.

Bishop Ohl took the chair and recognized Fr. Barber for a special presentation. Fr. Barber, as President of the Standing Committee and on behalf of all the diocese, asked Bishop Gulick to accept a gift of a pair of handtooled boots from Leddy's and a trip for two to Bermuda for himself and Mrs. Gulick. Bishop Gulick thanked the diocese for its gifts for himself and Mrs. Gulick.

The chair recognized Fr. Taylor for a series of courtesy resolutions directed to:

- The Episcopal Diocese of Kentucky

Fr. Taylor moved all the resolutions which were seconded from the floor and carried unanimously (text of all courtesy resolutions in the Appendix).

Bishop Ohl reminded the Convention of two priestly ordinations in the next few days—deacons Susan Slaughter and ClayOla Gitane—and recognized Walt Cabe, Chair of the Committee on the Dispatch of Business. Cabe reported that the Convention's work was accomplished.

Bishop Ohl blessed the Convention and declared it adjourned sine die at 2:50 P.M.

CANON 11

CORPORATION OF THE EPISCOPAL DIOCESE OF FORT WORTH

Sec. 11.1 Corporation of the Episcopal Diocese of Fort Worth is a non-profit benevolent and charitable organization organized under Texas Taws, also known as the "Diocesan Corporation". In addition to its regular powers, it may receive, hold, manage and administer funds and properties acquired by gift or by will or otherwise for the use and benefit of the Diocese and any Diocesan institutions.

Sec. 11.2 The management of its affairs shall be conducted and administered by a Board of Trusteees of five (5) elected members, all of whom are either Lay persons in good standing of a parish or mission in the Diocese, or members of the Clergy canonically resident in the Diocese, in addition to the Bishop of the Diocese who shall serve as Chairman of the Board or may designate the President or other officer of the corporation to serve as such. The Board of Trustees shall have the power and authority to conduct the affairs of said corporation in accordance with its charter and by-laws and in accordance with the Constitution and Canons of the Diocese from time to time adopted.

Sec. 11.3 One member of the Board of Trustees shall be elected at each Annual Convention and each member shall serve a term of five (5) years. The terms of members shall be so arranged that the term of only one (1) member shall expire annually. The Board of Trustees shall fill any vacancy which occurs on the Board until the annual election. The Bishop shall nominate the members of the Board of Trustees.

Sec. 11.4 The Board of Trustees shall adopt its own by-laws and shall elect such officers as its by-laws may require.

Sec. 11.5 The Board of Trustees shall submit a report at each Annual Convention covering its operations for the preceding fiscal year and showing its financial condition. If and when required by the Standing Committee of the Diocese, the Board of Trustees shall make such additional reports and furnish such additional information as may be requested. The books and records of the Board of Trustees shall at all times be open for inspection and examination by the Standing Committee of the Diocese or its representatives.

CANON 17

CORPORATION OF THE EPISCOPAL DIOCESE OF FORT WORTH

Sec. 17.1 Corporation of the Episcopal Diocese of Fort Worth is a non-profit and charitable organization organized under Texas laws, also known as the "Diocesan Corporation". In addition to its regular powers, it may receive, hold, manage and



administer funds and properties acquired by gift or by will or otherwise for the use and benefit of the Diocese and any Diocesan Institutions.

Sec. 17.2 The management of its affairs shall be conducted and administered by a Board of Trustees of five (5) elected members, all of whom are either Lay Communicants in good standing of a Parish or Mission in the Diocese or members of the Clergy canonically resident in the Diocese in addition to the Bishop of the Diocese who shall serve as Chairman of the Board or may designate the President or other officer of the Corporation to serve as such. The Board of Trustees shall have the power and authority to conduct the affairs of said Corporation in accordance with its charter and by-laws and in accordance with the Constitution and Canons of the Diocese from time-to-time adopted.

Sec. 17.3 One member of the Board of Trustees shall be elected at each Annual Convention and each member shall serve a term of five (5) years. The terms of members shall be so arranged that the term of only one (1) member shall expire annually. The Board of Trustees shall fill any vacancy which occurs on the Board until the annual election. The Bishop shall nominate the members of the Board of Trustees.

Sec. 17.4 The Board of Trustees shall adopt its own by-laws and shall elect such officers as its by-laws may require.

Sec. 17.5 The Board of Trustees shall submit a report at each Annual Convention covering its operations for the preceding fiscal year and showing its financial condition. If and when required by the Standing Committee of the Diocese, the Board of Trustees shall make such additional reports and furnish such additional information as may be requested. The books and records of the Board of Trustees shall at all times be open for inspection and examination by the Standing Committee of the Diocese or its representatives.
