Deanery Meetings – Agenda items include:

- <u>February</u> Orientation of new leaders; plan for the work the deanery will do together for the year
- <u>August</u> review diocesan budget for coming year; consider items to be brought before convention (nominations, resolutions, etc.)

• <u>October (*within 20 days of Convention*)</u> – election of dean & sub-dean (1 yr term); election of 1 deanery rep (3-yr term); consideration of convention matters (budget, resolutions, elections, constitution & canons, etc.)
